

Short Notice Inviting Tender

Sealed tenders on plain paper are invited by the General Manager, TFDPC Industrial Estate, Anandanagar on behalf of Tripura Forest Development & Plantation Corporation Limited, Agartala, Tripura for supply of 4(four) nos 2 (two) Ton, 5(five) Star Split Air Conditioner (AC) with Voltage stabilizer as per terms and conditions laid down below. Tender will be received in the office of the General Manager, TFDPC Industrial Estate up to 3 pm on 27.03.2018 and will be opened on the same day at around 3-30 pm, if possible, in presence of tenderer(s) or their authorized representative(s).

Terms and Conditions:-

1. Sealed Tender shall be received by post/Messenger at Office of the General Manager, TFDPC Industrial Estate, Anandanagar, West Tripura Pin-799004 up to 3 pm on 27.03.2018.
2. Rate shall be quoted both in words and in figures against each item separately including the delivery, Installation & Commissioning at TFDPC Industrial Estate, Anandanagar, West Tripura.
3. Taxes or other duties, if any, payable are to be indicated separately.
4. Tender envelop duly sealed must be superscribed with "TENDER for 4 nos 2 Ton, 5 Star split Air Conditioner with Voltage stabilizer".
5. The tenderer has to submit earnest money deposit for Rs.5,000/- (Rupees five thousand) only pledged in favour of "THE GENERAL MANAGER, TFDPC IE, ANANDANAGAR" alongwith the tender.
6. Voltage Stabilizer should have ISI quality certification and rating compatible with the power rating of the AC units.
7. Make of the AC units should be of any of the four brands, namely Voltas / Samsung / LG / Whirlpool.
8. Rate quoted should remain valid for minimum 6 (six) months.
9. The successful tenderer shall have to supply the tendered items with all accessories etc to the office of the General Manager, TFDPC Industrial Estate, Anandanagar as specified in the supply order within 15(fifteen) days from the date of issue of the supply order.
10. Payment will be made after supply, installation, commissioning and trial run of items.
11. The undersigned reserves the right to accept or reject any rate quotation including the lowest one without assigning any reason.
12. Taxes as applicable will be deducted at source as per rules.
13. All disputes resulting from this tender notice and actions thereon shall be settled under the jurisdiction of the Tripura High Court.
