1. Petrol Chain Saw

- v) Oil bath, warm-gear type.

3. Quantity required: 3 sets

Terms and conditions:-

- i) EMD for Rs. 10,000/- (Rupees ten thousand) only pledged in favour of Executive Director, TFDPC Ltd. Agartala is to be deposited along with tender without which no tender will be treated valid for acceptance.
- ii) EMD of the successful bidder will be retained till satisfactory supply of the materials. On satisfactory supply of the material, EMD will be released. However, for the successful bidder, EMD will be released on finalization of tender on receipt of application from the bidder.



- iii) Registration certificate of the Firm/Manufacturer along with experience certificate are to be attached along with the tender.
- iv) Rate for each quotation should be quoted both in words and figures.
- v) Make of the tools and machineries is to be mentioned against each item.
- vi) Taxes as applicable will be deducted from the bill.
- vii) Materials should be supplied within 45 days from the date of issue of supply order.
- viii) On supply of materials, demonstration is to be arranged at the cost of responsibility of the tenderer.
- ix) Payment will be made on successful of supply and demonstration of material against Bill to be submitted in duplicate.
- x) Quantity may vary at the time of procurement.
- xi) The undersigned shall have the right to accept or reject any tender including the lowest one without assigning any reasons.
