1. Sealed Quotations shall be received by post/Messenger in the Office of the General Manager, TFDPC Industrial Estate, Anandanagar, West Tripura, PIN-799004 up to 3 pm on 31.05.2018.
2. Rate shall be quoted both in words and in figures against each item separately including the delivery at TFDPC Industrial Estate, Anandanagar, West Tripura.
3. Taxes or other duties, if any, payable are to be indicated separately.
4. Envelop with the rate quotations for the item duly sealed must be superscribed with "RATE QUOTATION for 42 Inches Wheel for TFDPC-IE".
5. Rate quoted against the item should remain valid for at least 6 (six) months.
6. The successful bidder shall have to supply the quoted items with all accessories, etc. to the office of the General Manager, TFDPC Industrial Estate, Anandanagar as specified in the supply order within 15(fifteen) days from the date of issue of the supply order.
7. Prior to supply of the item its specification may be obtained on inspection of the 'original one' which is already lying in the TRWF Unit of the TFDPC Industrial Estate, Anandanagar, West Tripura.
8. Supplied item should have quality certification and also the specifications exactly matching the 'original one'. Quantity of item may increase or decrease as per requirement.
9. There should be an warranty for at least two years for the item to be supplied in case of fault, if any, is witnessed which may lead in making the wheel non-functional.
10. Payment will be made after supply and satisfactory trial run of items.
11. The undersigned reserves the right to accept or reject any rate quotation including the lowest one without assigning any reason.
12. Taxes as applicable will be deducted at source as per rules.
