2. The year of make of the vehicle should not be before 2016. The bidder should submit Certificate/documents regarding the year of make.
3. The vehicle is to be mechanically in good condition.
4. Tender should accompany with copy of Registration certificate of the vehicle without which the tender will not be considered.
5. Subsequently the undersigned any seek for Road tax clearance certificate Insurance papers, Income tax clearance certificate fitness certificates license PAN card etc. of both vehicles to the tender whose tender is accepted.
6. The tenderer offering the tender acceptance by the undersigned will sign an agreement with the undersigned on Non-judicial Stamp paper for running the vehicle for 1(one) year from the date of acceptance of the tender.
