Sealed tenders for hiring of 1(one) no Mahindra Bolero Power + ZLX MH (Make 2017 or Latest model) are invited by the undersigned on behalf of Tripura Forest Development & Plantation Corporation Limited, (A Govt. of Tripura Undertaking) as per terms & conditions laid down below. The tenders will be received at the office of the Managing Director, TFDPC LTD. Abhoynagar, Agartala **up to 3.00 p.m. on 20.04.2018** and opened on the same day if possible.

TERMS & CONDITIONS

- 1) The vehicle will have to attend duty normally from 9.0 AM to 8.0 PM daily even on holiday, duration of which may get increased depending upon requirement.
- 2) The year of make of the vehicle should not be before 2017. The bidder should submit Certificate/documents regarding the year of make.
- 3) Each tender should be accompanied with earnest money of Rs.5,000/- (Rupees five thousand) only in the form of 'Deposit at Call' pledged in favour of Executive Director, TFDPC LTD. on any scheduled Bank payable at Agartala, without which no tender will be accepted. Earnest money of the successful bidder will remain deposited with TFDPC Ltd as security deposit till engagement period is over. EMD of the unsuccessful bidder will be released on getting prayer from the concerned bidder
- 4) Registration Certificate, Road Tax clearance Certificate, Income Tax Clearance Certificate, fitness Certificate & Driving License of Driver will have to be submitted along with the tender.
- 5) The vehicle of the successful bidder will be engaged initially for a period of 1(one) year, which may be extended.
- 6) The owner of the vehicle will have to provide driver and all expenses related to wages of driver, cost of fuel & other consumable, maintenance expenses and all kinds of taxes.

- 7) The vehicle will be run and maintained by the owner at his risk & TFDPC LTD. will not be responsible for any loss or damage of the vehicle or any part thereof during the period of engagement.
- 8) In case of any mechanical disturbance, the owner will have to arrange another same model vehicle at his own risk & cost.
